HAYDEN CANYON CHARTER OVERVIEW

Hayden Canyon Charter's Mission is "Achieving breakthroughs in academic excellence and character development by inspiring passion for inquiry and life-long learning - utilizing hands-on discovery, real-world application, collaboration and community; preparing each student for engagement in productive, thoughtful citizenship."

Hayden Canyon Charter (HCC) utilizes an expeditionary approach to learning. Learning modules are project based with students participating in hands-on activities that incorporate a variety of subjects into their projects. Students engage in field work related to the modules they are studying to ensure the activities are meaningful. Our students hike at least once a week for an hour each time they go out (with the exception of¹/₂ day kindergarten) during which time they engage in thoughtful conversation, study of nature, and incorporate classroom learning in an outdoor environment.

Students learn empathy, compassion and the value of working together to create a school-wide culture building a safe and healthy community. Hayden Canyon Charter uses a CREW model in which we believe everyone works together for the good of all. "We are crew, not just passengers". Through a variety of real-world assessments and state testing, HCC students demonstrate mastery of the subject matter they have learned, and have the ability to share that mastery at Exhibitions Nights where projects are displayed for the community to enjoy.

HCC's learning approach is grounded in evidence-based best practice, and designed to provide active, engaging, equitable, and rigorous learning in a caring, collaborative, hands-on, project-based environment. Students learning in such an environment will find their experience to be meaningful, rich and rewarding.

Students at HCC develop productive habits of mind and character, work ethic, and 21st Century competencies such as effective collaboration and teamwork, communication, use of technology, creative and critical thinking, and resourceful problem solving.

- 13. Hold an education specialist or doctorate degree or complete a comparable post-master's sixth year program at an accredited college or university.
- 14. Commitment to hold to the ideals, values, and model upon which the school was founded, regardless of outside pressures and/or influences.
